INVITATION TO TENDER

TENDER 03/2013: SUPPLY AND DELIVERY OF WATER METERS

Tenders are hereby invited for the supply and delivery of water meters to Thembelihle Local Municipality.

Tenders must be submitted on the original documents and remain valid for ninety (90) days after the closing date of the tender. Enquiries pertaining to the specifications can be addressed to Mr Evan Painting at telephone (053) 203 0951. Enquiries pertaining to the completion of the documents can be addressed to Ms Nogoli Jaxa at (053) 203 0951.

A set of tender documents can be obtained at a non-refundable cost of R150 per set from Ms Nogoli Jaxa during office hours at municipal offices at telephone (053) 203 0008. Payments must be made by cash or crossed cheque payable to the Thembelihle Local Municipality. No tender documents will be e-mailed to any prospective bidders. Additional sets of tender documents are available at a cost of R150 per set.

Fully completed tender documents must be placed in a sealed envelope and placed in the tender box in the Foyer at the Thembelihle Local Municipal offices corner Mark and Church Streets, Hopetown not later than time and date stipulated or be mailed to reach the Tender Box, Thembelihle Local Municipality, P/Bag X3, Hopetown, 8750 before the specified closing date and time. The envelopes must be endorsed clearly with the number, title, tenderer's name and closing date and time of the tender as above.

The tender will be evaluated on the **90/10 Preference Points** system as prescribed by the Preferential Procurement Policy Framework Act 5 of 2000.

Receipts will be issued on request only for tenders handed in during office hours from Mondays to Fridays. Receipts will not be issued for tenders placed in the tender box after hours or which are received by mail.

The tender box will be emptied just after 12:00 on the closing date as above, hereafter all bids will be opened in public. Late tenders or tenders submitted by e-mail or fax will under no circumstances be accepted.

The Municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The Municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

It is expected of all Bidders who are not yet registered on the Municipality's Accredited Supplier Database to register without delay on the prescribed form. The Municipality reserves the right not to award tenders to Bidders who are not registered on the Database.
