TENDER NOTICE AND INVITATION TO TENDER

The THEMBELIHLE LOCAL MUNICIPALITY invites tenderers from **mechanical & electrical engineering** contractors for the **Upgrading of the existing raw water abstraction point from the Orange river in Hopetown.**

It is estimated that tenderers should have a CIDB contractor grading designation of **5 ME** or higher. Contractors registered as potentially emerging (PE) enterprises with the CIDB who are registered in one contractor grading designation lower than that required in terms of the total sum tendered are also eligible to tender.

Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data are eligible to submit tenders.

The Thembelihle Local Municipality Procurement and Supply Chain Management Policies, the Preferential Procurement Policy framework Act, Act No 5 of 2000 and the regulations promulgated under this act shall apply in the adjudication and awarding of the tender.

The physical address for collection of tender documents is: **Thembelihle Local Municipality, c/o Church and Mark Streets, Hopetown, 8750.** Documents may be collected during working hours after 09:00 as from **7 March 2014.** Late or incomplete; unsigned; electronically and faxed bids will not be accepted.

A non-refundable tender deposit of R 300.00 payable in cash only is required on collection of the tender documents.

Thembelihle Local Municipality does not bind itself to accept the lowest bid or any tender and reserves the right to accept the whole or part of a bid or to accept bids from more than one Service Provider.
