Thembelihle Local Municipality is requesting quotations from Service Providers who have proven experience in Financial and GIS database integration preferably at a Local Authority. The ultimate aim of the Municipality is to ensure that water and electricity losses are minimised and that the Debtors' database is more accurate and up to date to ensure that Revenue is maximised. For this reason the project aims to ensure that:

- i. The information that the municipality has on its billing system is accurate and correct;
- ii. The customer information is accurate and complete;
- iii. Preventative controls are implemented to ensure future additions of new customers' data and changes of data are complete and accurate;
- iv. That all properties in the municipal area are taxed and captured on the municipal valuation roll and billing system;
- v. That Revenue sources are maximised;
- vi. That the causes of electricity and water losses are determined and rectified (excluding replacement of meters); and
- vii. That cost cutting measures be instituted to prevent losses.

It will thus be necessary to extract and verify valuation information from the financial system and reconcile with GIS information and the valuation roll to ensure that the information on all properties are captured correctly on the billing system in respect of name of registered owner, current usage of property, zoning of property, size of property, land and improvement value of the property as per valuation register. A further step would be to compare the debtor type to the latest tariff register as approved during the latest budget process to ensure that consumers are levied correctly for assessment rates and services rendered to them.

It is envisaged that the project will have two phases namely:

Phase 1:

By making use of GIS mapping:

- i. Determine electricity and water losses and understand the various causes of electricity and water losses in the municipality.
- ii. Identify, plan and implement projects to control electricity and water losses.
- iii. Reduce electricity and water losses if higher than 15% to 15% in the short to medium term, and to 10% in the long term.
- iv. Audit of electricity and water meters (bulk and domestic).
- v. Extract and verify meter information from the financial system in respect of low or no consumption readings.
- vi. Implement reporting system on faulty meters.

Phase 2:

- i. Identify potential Revenue in the Municipality (e.g. meters not on system, households not on system, etc.); and
- ii. Implement control measures to ensure these income sources are captured on the system and billed on a monthly basis.

All prospective Service Providers are requested to provide quotations for these two phases separately. Payment of the quoted amounts will be paid when the respective phases are signed off as being complete by the Chief Financial Officer. In other words only two payments will be made; one on the completion of phase 1 and the second on the completion of phase 2.

2. Tax Clearance Certificate

(a) A valid original Tax Clearance Certificate must accompany the bid documents unless the bidder is registered on the Accredited Supplier Database of the Municipality and the Municipality has a valid original Tax Clearance Certificate for the bidder on record. 4. MBD 8: DECLARATION OF BIDDER'S PAST SUPPLY CHAIN MANAGEMENT PRACTICES

5. MBD9: CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

¹ Includes price quotations, advertised competitive bids, limited bids and proposals.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)

 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
