Tenders will be pre-evaluated on functionality and bidders scoring less than 70 out of 100 points for functionality will not be considered for further evaluation. The tender will be further evaluated on the 80/20 Preference Points system as prescribed by the Revised Preferential Procurement Policy Framework Act 5 of 2017

The tender box will be emptied just after 12h00 on the closing date as above, hereafter all bids will be opened in public. Late tenders or tenders submitted by e-mail or fax will under no circumstances be accepted.
