Request for Proposals are hereby invited by Thembelihle Local Municipality in terms of Section 111 of the MFMA (No 56 of 2003) and Clause 12(1) of the Municipal Supply Chain Management Policy for the **PROVISION OF TRAINING SERVICES FOR 200 MEMBERS ON SKILLS PROGRAMME FROM THE QUALIFICATION 23475 – NATIONAL CERTIFICATE: WATER RETICULATION SERVICES – NQF LEVEL 2**

Bids are herewith invited from suitably qualified Service Providers to provide the Municipality with TRAINING SERVICES for a period of one year.

Sealed bids, endorsed with the corresponding bid description “**PROVISION OF TRAINING SERVICES FOR 200 MEMBERS ON SKILLS PROGRAMME FROM THE QUALIFICATION 23475 – NATIONAL CERTIFICATE: WATER RETICULATION SERVICES – NQF LEVEL 2**”, must be placed in the Bid Box at the offices of Thembelihle Municipality, Church Street, Hopetown.

All bids must reach Thembelihle Municipality not later than **12:00 on Tuesday, 21 January 2020** being the closing date and time, after which the proposals will be opened in public. Late bids or bids submitted by e-mail or fax will under no circumstances be accepted.

A compulsory briefing session will be on **14 January 2020 at 14h00** at the Council Chambers of Thembelihle Municipality in Church Street.

Bid Documents will be available during office hours as from **Monday, 06 January 2020**. Bids must be submitted on the original documents and remain valid for ninety (90) days after the closing date of the bid request. The tender will be evaluated and adjudicated on functionality and points will be awarded on 80/20 in terms of the Revised Preferential Procurement Regulations, 2017 of the PPPF Act, Act No. 5 of 2000.

## 1. The following are the minimum requirements:

### Service provider must

- Be accredited with EWSETA on qualification 23475 – NATIONAL CERTIFICATE: WATER RETICULATION SERVICES – NQF LEVEL 2
- Be able to deliver the skills programme comprised of the following unit standards: 12133, 14017, 12033 (making up a total of 23 credits)
- Have the currently registered EDT practitioners for assessments and moderations of the PoEs
- Be able to deliver the programme concurrently across the beneficiary municipalities
- Produce implementation plan that can be implemented and completed within three months from the date of the award of the tender
- In cases of a joint venture/subcontracting, all the service providers must be fully compliant with SARS, BBBEE, company registration documents (CIPC), be registered on CSD.
- Applications with joint ventures/subcontracting with the Northern Cape based skills development providers will be given preference.
- Prospective applicants should have a Northern Cape based office

## 2. Functionality Assessment is required

2.1 Bidders that meet the requirements set out in point 1 will be invited for presentation on functionality Assessment

2.2 The tentative date for the presentations will be communicated.

The municipality does not bind itself to accept the lowest or any bid and reserves the right to accept the whole or only part of a bid.

The Municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The Municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

It is expected of all Bidders who are not yet registered on the Municipality's Accredited Supplier Database and on the CSD to register without delays. The Municipality reserves the right not to award bids to Bidders who are not registered on the CSD.
