Thembelihle Local Municipality invites Suppliers of Water purification chemicals to submit tenders for the Supply & Delivery of Water & Wastewater Purification Chemicals for Hopetown & Strydenburg for a period of three years.

Tenders must be submitted on the original documents and remain valid for (90) days after the closing date of the tender.

Payments must be made by means of an electronic funds transfer to Thembelihle Municipality or paid in cash. Deposits made via EFT will have a waiting period of one day. Fully completed tender documents must be placed in a sealed envelope and placed in the **tender box at the offices of Thembelihle Local Municipality by not later than 12h00 on the 12 November 2021** before the specified closing date and time. The envelopes must be endorsed clearly with the number, title and closing date of the tender as above.

The tender will be evaluated on the 80/20 Preference Points system as prescribed by the Revised Preferential Procurement Policy Framework Act 5 of 2017.

The tender box will be emptied just after 12h00 on the closing date as above, hereafter all bids will be opened in public. Late tenders or tenders submitted by e-mail or fax will under no circumstances be accepted.

It is expected of all Bidders to be registered on the Central Supplier Database (CSD). Unregistered bidders will be disqualified immediately.

The following conditions will apply:

- Prices quoted must be inclusive of VAT
- Bids will be evaluated in accordance with Method 2: Financial offer and preference, qualifying tender offers will be evaluated according to the 80/20 point system, where the financial offer will account for 80 points and preferences for 20 points. All the returnable forms must be completed and submitted with the bid. **Bidders are required to, together with their bids, submit a valid B-BBEE Status Level Verification Certificate or certified copies and or an original Sworn Affidavit thereof to substantiate their B-BBEE rating claims**
- Bids that are late or incomplete will not be considered, whilst the lowest or only bid will not necessarily be accepted. Bids per fax or e-mail will also not be considered.
- **An original tax clearance certificate, and/or the document issued by SARS indicating the tax clearance PIN**
- Bids must be accompanied with documentation to verify competency
- The 80/20 preferential points system will be applied to evaluate this tender. **No B-BBEE points would be allocated if a certified copy of the B-BBEE certificate or an original Sworn Affidavit is not attached to the bid document.**
- Certified copies of originals of company registration documents and ID documents for all directors
- Bidders are expected to submit a Rates and Taxes Account of the company and its directors not older than 90 days from the closing date of this tender. Bidders and directors that are renting premises and are not responsible for the Rates and Taxes Account, should submit a copy of the rental agreement indicating such. Bidders and directors with a Rates and Taxes accounts that have outstanding balances older than 90 days, will be disqualified. Failure to submit a rates and taxes account will lead to automatic disqualification. Refer to TLM SCM Policy Section 13(a)(v) and Section 40(c)(i).
