Request for Proposals are hereby invited by the Thembelihle Local Municipality in terms of Section 111 of the MFMA (No 56 of 2003) and Clause 12(1) of the Municipal Supply Chain Management Policy for **REQUEST FOR PROPOSALS FOR TURNKEY PROFESSIONAL ELECTRICAL ENGINEERING SERVICES.**

The Service Provider must have a Project Leader who is a qualified and experienced Professional Electrical Engineer registered with the Engineering Council of South Africa as a Professional Engineer. The Tenderers must also have suitably qualified engineers as support staff. A CIDB Grading **3PE** or Higher is required.

The Employer's objective is to appoint a suitable service provider on a Turnkey basis for the year ending June 2023. During the period the service provider must address all the municipality's challenges by sourcing grants and/or other forms of funding to identify and implement projects that will address the challenges.

1.1 Scope of Works

The proposal should address the following:

- Services Provider's Staff and Resources
- Review of Existing Designs
- Electrification of 40 Erfs
- Close Out and Handover

A COMPULSORY SITE INSPECTION will be held at 11:00 on TUESDAY, 6 October 2022, at the THEMBELIHLE TECHNICAL SERVICES BOARDROOM in HOPETOWN (GPS COORDINATE: S 29° 37′ 40′S; 24° 04′ 55′E). DOORS WILL BE CLOSED AT 11H00 SHARP. Tenderers, who do not attend the compulsory site inspection, will expose their tenders to rejection. Tenderers who arrive late will not be allowed to participate in the tender process.

Only Tenderers who satisfy the eligibility criteria stated in the Tender Data are eligible to submit tenders. Tenders will be evaluated and adjudicated in line with the Supply Chain Management Policy of the municipality based on the functionality, pricing and BBBEE.

Tender documents will be made available at the compulsory clarification meeting. A non-refundable tender deposit of R 1 000.00 (One Thousand Rands) per document, is payable in cash or EFT to the Thembelihle Local Municipality.

- Proposals will be subject to an **evaluation criterion** as set out in the Tender Document.
- Tenderers must be registered on the Central Supplier Database
- All documentary proof requested in the tender document (e.g. tax clearance certificate, BBBEE certificate, etc.) must be submitted along with the tender document

- Tenders may only be submitted on the original tender document as issued.
