Information Statement in terms of Chapter 2, Regulation 5 of the Municipal Asset Transfer Regulations (MATR) (R.878)(2008):

- 1. The valuation of the capital asset to be transferred or disposed and the method of valuation used to determine that valuation. The market valuation carried out by the Municipal Valuers using comparable sales method, estimate the market value of the subject properties as shown in the table above, escalating at a market-related rate.
- 2. Reasons for the proposed transfer and disposal of the assets:

 The Municipal Council have confirmed that the property is not required for the provision of the minimum level of basic municipal services.
- 3. Any expected benefits to the Municipality that may result from the transfer or sale

 The Municipality will be catalysing underutilised capital assets for economic growth and higher-intensity use.
- 4. Any expected proceeds to be received by the Municipality resulting from the transfer or disposal:

It is anticipated that the Municipality will receive the proceeds in the form of a market-related sales price and future rates revenue.

5. Any expected gain or loss that will be realised or incurred by the Municipality arising from the transfer or disposal:

The normal costs related to the advertisements will be incurred by the Municipality. The purchaser will be responsible for the transfer costs.
