PROVISION OF A TRACKING SYSTEM FOR THEMBELIHLE MUNICIPALITY

You are hereby requested to provide Thembelihle Municipality with a quote for a tracking system that provides for self-managed GPS tracking devices for all our vehicles including moveable plant and some equipment to track the whereabouts of these items via internet or on the Managers' cellphones. The system should include speed-, move-, and Geofence alerts, trip reports and logbooks. The municipal's own contract phone SIM card must be used to receive alerts and show the movement.
